- Up to \$500 in reimbursements

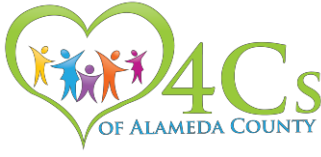

**INCOME ELIGIBILITY GUIDELINES 2023-2024  
Effective July 1, 2023**

<b>Persons in Household</b>	<b>Annual Income Extremely Low (30%)</b>	<b>Annual Very Low Income (50%)</b>	<b>Annual Low Income (80%)</b>
<b>1</b>	\$31,050	\$51,800	\$78,550
<b>2</b>	\$35,500	\$59,200	\$89,750
<b>3</b>	\$39,950	\$66,600	\$100,950
<b>4</b>	\$44,350	\$73,950	\$112,150
<b>5</b>	\$47,900	\$79,900	\$121,150
<b>6</b>	\$51,450	\$85,800	\$130,100
<b>7</b>	\$55,000	\$91,700	\$139,100
<b>8</b>	\$58,550	\$97,650	\$148,050

If you live in unincorporated areas of Alameda County, Hayward, Fremont or Union City and are income eligible based on the chart above, you may be eligible to participate in 4Cs CCIP program. If you live in unincorporated areas of Alameda County or the city of Fremont, you may be able to participate if your income is slightly higher than what is listed on this chart. Contact a staff person for details.

**Income Eligibility Requirements**

CCIP participants must meet the income guidelines listed above. For each person in the household who is earning an income, we need one of the following forms of income verification:

- ✓ Signed and dated IRS 1040 Form from last year (pages 1&2), and schedule C if applicable
- ✓ Copy of most recent paystub showing gross income earnings
- ✓ Copy of eligibility certification, e.g., CalFresh, CalWORKS, etc.
- ✓ Copy of the most recent income statement from public benefits, e.g., social security, pension, etc.

If you have been screened for eligibility through another 4Cs program, e.g., Child Care Food Program, CalWORKS Child Care, please let us know. With your permission, we may be able to access information that is already on file.
